CALL FOR CONTRIBUTIONS

The African Training and Research Centre in Administration for Development (CAFRAD) is a pan-African intergovernmental organization created in 1962 at the initiative of Morocco and several African governments, with support from UNESCO. It is the first pan-African centre dedicated to training and research aimed at strengthening public administration and governance systems across the continent.

I. BACKGROUND

Since 1967, CAFRAD has published its biannual journal, *Cahiers Africains d'Administration Publique* (African Journal of Public Administration), a scholarly publication focused on public administration issues in Africa and around the world. In this context, CAFRAD works in partnership with numerous international organizations, including the African Union, the European Union, the United Nations, UNDP, UNDESA, and the OECD.

In 2026, the journal will enter a new phase after decades of contributing significantly to African public administration literature. It will be renamed the *African Review of Smart Public Administration (RAAPI)* and will focus on ongoing administrative transformations and the continent's development challenges through a multidisciplinary, interdisciplinary, and transdisciplinary lens. This reform is essential to align the publication with

the evolving needs and expectations of modern public administrations and to

enhance its overall quality and relevance.

The Review will examine a wide range of topics, including

benchmarking, best practices, and innovative approaches in public

administration, governance, management, diplomacy, trade, and sustainable

and inclusive development. It will also address emerging challenges shaping

the future of public action, such as digital, intelligent, and sustainable

transitions; Africa's socioeconomic transformations; public values; the

evolution of public institutions; and political, institutional, and legal

developments.

In addition, the Review will explore global security concerns,

geopolitics, geostrategy, geoeconomics, and the shifting configuration of the

international order. It aims to help Africa anticipate the profound and

multifaceted transformations driven by artificial intelligence. Its relevance

will be strengthened by a focus on new methods, tools, and principles of

authentic, ethical, transformational, situational, and contingency leadership.

The Review will serve as a handbook—a guide to governance in an

increasingly globalized and turbulent world where information, though

abundant, is both scarce and strategic. Valuable, reliable intelligence is

generated by the most capable analysts. For this reason, the Review will

function as a monitoring platform that readers can use to identify and

anticipate risks, threats, and opportunities. It will be a solutions-oriented

publication addressing professional and capacity-building challenges.

Academics, experts, and researchers working on African issues—

particularly those related to the theme of the next issue, "The Digital,

Ecological, and Economic Transformations of and in Africa"—from

both the public and private sectors are invited to submit articles on this

topic. You are therefore invited to express your interest by sending us the

summary of your article proposal (including the topic and the issue

III. WRITING GUIDELINES, REVIEW PROCESS, AND SELECTION **CRITERIA**

The selection of projects will be carried out by the experts of the permanent scientific committee. Each research proposal will undergo a critical review by the members of the permanent scientific committee with the aim of providing its author with constructive and relevant feedback, as well as suggestions for possible improvements. The article proposals will be assessed based on the following criteria:

• Relevance of the topic

- Clarity and precision of the research question
- Appropriateness of the conceptual framework
- Quality and rigor of bibliographic references
- Consistency of methodological and epistemological choices
- Quality of the analysis and discussion of results
- Contribution to research on the theme

- Contribution to existing knowledge
- Quality of writing

Authors must ensure that their submissions meet the following requirements:

- Manuscripts must demonstrate strong writing skills and adhere to scientific rigor, ethical standards, and professional norms.
- Contributions must be original, unpublished, and not under consideration by any other academic journal.
- Articles should range between 15 and 30 pages, including appendices, footnotes, and bibliographic references, and must follow universal academic standards.
- The manuscript must be written in Bookman Old Style font (size 14 for Arabic; size 12 for French and English), with 2.5 cm margins and 1.5 line spacing.
- The title of the article should appear in bold, using Bookman Old Style, size 16.
- The abstract, written in the language of communication and in English or French, should be between 150 and 300 words. It must be concise, highlight the main points of the analysis, and include five keywords.
- The introduction should provide adequate background information, clearly presenting the study's context and enabling readers to assess its significance and evaluate the results.
- The main body of the article should be organized logically, with sections and subsections clearly numbered (e.g., 1., 1.1, 1.2, 2., 2.1, 2.2, etc.). The introduction and conclusion should not be numbered.
- Submissions must be accompanied by the author's curriculum vitae.
